**NOTICE TO OUR VENDORS:**

Capital City Cruisers has been notified by the California State Board of Equalization that any party selling anything at our show must hold a valid California Seller's Permit. We are required to verify with the state that the permits are valid prior to allowing any party to sell anything at our show or we face a fine of \$1,000 per violation. Consequently, all sellers are required to provide us with their Seller's Permit Number on or before September 20, 2015 in order to allow us time to verify that the number is valid. Last year we found that several numbers were expired, invalid, or not registered to the seller using them. No matter who you are - a church group or service club, a crafter selling crafts, a dealer selling antiques, or an individual selling car parts - You Must All Have Valid Seller's Permit!
